TERMS AND CONDITIONS

Payment: As stated above, the 25% deposit must be paid at the time of requesting to book the venue. All fees will be charged to the payment on file, with half of the remaining balance charged two weeks prior to the event date, and the final payment charged on the day of the event. Any additional charges incurred that are not covered by the base package cost will be charged after the event to the payment on file. Please note there is a 3.5% convenience fee for all credit card transactions.

Venue Access: Coaches may access the facility 15 minutes prior to the practice start time. All team attendees must leave the reserved area at the scheduled end time. An additional charge will be incurred if your practice exceeds gym scheduled time.

Clean up: Coaching Staff are expected to place any trash and debris inside designated receptacles prior to vacating the reserved area. Failure to do so will result in an additional **cleaning fee of \$50**. Coaches and staff must comply with the following restrictions:

- No equipment may be left for storage after team practices conclude.
- No outside patrons may be permitted on campus before and after agreed practice times outside of agreed rental times unless authorized by authorized staff.

THE FINE PRINT CONTINUED

Additional Coaching Staff: This party contract's final price is based on the number of athletes/guests in attendance team event/practice. If this number exceeds the amount indicated on the package requested, additional per-guest fees will apply as stated in the package description.

Quartly Rental agreement: Rental space availability is subject to fluctuate each season based on demand and gym availability. Parties may apply for monthly gym rental but are not promised gym time/availability based off of prior business with our gym facility.

Guest Conduct: All guests are expected to behave responsibly at all times. Guests must be supervised by an adult at all times. South Walton Academy will issue a single warning for unruly conduct prior to asking guests to leave the premises.

Cancellation Policy: If you cancel the event with less than a 72-hour notice, then you waive the right to the deposit, but you will not owe anything further for the cancelled event. If you cancel the event with more than a 72-hour notice, then, so long as you reschedule the event to occur within 30 days of the originally scheduled event, then we will apply the deposit to the cost of the event. If you no-show the event, then you waive the right to recover the deposit and authorize us to charge your credit card for the full amount of the event. If you walk out on the event prior to payment, then you waive the right to recover the deposit and authorize us to charge your credit card for the full amount of the event. If an Act of God or weather event causes our facility to close, your party will be rescheduled. No refunds are provided for an Act of God or weather event.

Liability: By signing this contract, you release South Walton Academy from any potential liability. You agree to indenify and hold harmless South Walton Academy and its employees for any damages, loss, or injury that may occur. **Proof of liability insurance is required before any rental dates are will be approved.**

Loss of Property: Should South Walton Academy property be lost or damaged due to the actives of any of your party's participants, you agree to reimburse South Walton Academy for replacement or repair of said property.

By signing this team party contract, you are submitting a formal request for a gym rental reservation. You will receive an email confirmation once your event contract is reviewed an accepted. Furthermore, you are agreeing to hold your entire athletic program/buisness responsible for the terms of this contract without limitation. Please note that a reservation cannot be confirmed without full payment of the deposit listed in this contract. **A 3.5 % credit card fee will be added to final gym rental payment***
